6. After I entered my telephone number onto the form I started receiving numerous robocalls. I told the callers to stop calling, but the calls kept coming. They were so frequent that I decided to change my telephone number.

14 five text messages selling Freedom's debt settlement products. I never consented to receive those

8. Throughout this lawsuit, I have worked with my lawyers by answering their questions and responding to Defendants' written questions.
