28 The Court ordered the parties to file, consistent with this District’s Procedural Guidance
on Class Action Settlements, a post-distribution accounting detailing the payments disbursed in
connection with the settlement. *See* Dkt. 367. The parties submitted status reports on November
1, 2024 and January 30, 2025 indicating that the settlement administrator was in the process of
performing a second distribution of settlement funds to settlement class members. *See* Dkts. 369,
371. The parties indicated that they would submit the final accounting after all funds had been

1 disbursed. The Court set a March 21, 2025 deadline for the parties to submit a joint statement
2 about the final settlement accounting and a March 28, 2025 compliance deadline. Dkt. 372.

3 The parties respectfully submit the attached declaration from Settlement Administrator,
4 A.B. Data, describing the payments that have been made in connection with the settlement to
5 date and attaching a Post Distribution Accounting document as required by this district's
6 procedural guidance on class actions. *See* Ex. 1 (Declaration of Markeita Reid on Behalf of A.B.
7 Data, Ltd. in Support of Final Post-Distribution Accounting). The parties will post the Post
8 Distribution Accounting document on the case website.
